**REQUIREMENT / PROCEDURE FOR ADMISSION TO
LLB (04YEARS)**

A. Eligibility:
For LL.B (04Years)

- i. Intermediate or Equivalent from recognized Institute / A-Level with equivalence Certificate from IBCC) with at least 50% Marks in the relevant degree.
- ii. Candidate must have completed Law Admission Test (LAT) being conducted by Higher Education Commission (Minimum 50 Score).
- iii. Candidate who have appeared in the final examination of HSSC or equivalent/Grade 12 Education and awaiting results.

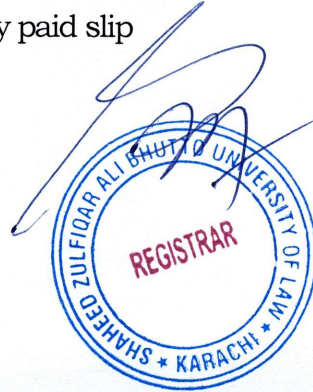
B. Admission Procedure:
LL.B (04 Years)

The candidate shall fill and submit the Admission Forms (With Scanned Copies of Required Documents) Via: Online Admission Portal.

The Candidate shall attach / Upload the following documents while applying online:

- a. Attested Copy of LAW ADMISSION TEST (LAT) VALID CERTIFICATE.
Mandatory (Only for LLB Admission)
- b. Attested Copy of Applicant, Parents/Guardian CNIC
- c. Attested Copy of Domicile & PRC C
- d. Attested Copy of Passport Size Photograph
- e. Attested Copy of Metric Certificate & Mark sheet
- f. Attested Copy of Intermediate/ equivalent Mark sheet & Certificate
- g. Migration Certificate/ Equivalence Certificate if required.
- h. Affidavit (for Abiding by the Code of Conduct of University)
- i. Affidavit (for Result Awaited Student only)
- j. Disable Certificate / Lawyer / Minority / Balochistan Quota (If applicable)
- k. Fee paid Deposit Slip & Pay order copy / Kuick pay paid slip



C Admission Criteria:

- i. Application for provisional admission will be considered on the basis of eligibility, merit, availability of seats.
- ii. Final merit list will be prepared by the Admission Committee according to the following weighted average formula:
 - a) 70 % weightage will be for the mark obtained in the LAT conducted by HEC.
 - b) 10% weightage will be for the marks obtained in the Intermediate Examination.
 - c) 10% weightage will be for the marks obtained in the Matric Examination.
 - d) 10% weightage will be for the mark obtained in the Interview.
